I agree to pay the rate for lodging. I understand that there may be fees to make changes to the reservation dates and agree to pay those fees.

I further agree to pay all costs and charges for special services requested and all necessary costs for pet/s during the time said pet/s is/are in the care of the kennel. These costs/charges are due upon check out.

By signing this contract and leaving my pet/s with the kennel, I certify to the accuracy of all information given about the said dog/s and/or cat/s.

I further understand and agree that in admitting my pet/s to West Maui Kennels, staff/agents/volunteers have relied on my representation that my pet/s is/are in good health and have not harmed or shown very aggressive towards any person or any other dog/cat. I hereby indemnify West Maui Kennels, it owners, staff, agents and representatives, with regard to any claims arising from the aggressive behavior of my dog/s and/or cat/s.

I agree that West Maui Kennels will not be responsible or liable for lost, stolen or damage to personal property belonging to me.

I understand and agree West Maui Kennels, employees, volunteers, agents and representatives will not be liable for any problems which may develop, including but not limited to, loss by fire, theft, running away, death or injury. I understand that my pet/s will be in a nature environment, running and playing (possibly with other pets) and that with this type of activity there is risk of sprains, cuts, and other injuries inherent in rough play and running around. I hereby release and discharge West Maui Kennels, its employees, volunteers and representatives from any and all claims, damages, liability and/or causes of action of any kind arising from my pets attendance at West Maui Kennel except where any such loss is caused by an intentional act of an employee, volunteer, agent or representative of West Maui Kennels.

I hereby initial to represent to West Maui Kennels that my pet/s has/have not been exposed to a communicable virus or disease (Dogs: Parvo, Distemper and Bordetella; Cats: airborne viruses: rhinotracheitis, calicivirus and panleukopenia) within a 30 day period prior to the date of check in. Further I swear that my pet/s has/have all the necessary vaccinations within the necessary time frame as specified by West Maui Kennels and that honest and correct evidence of these vaccinations has been provided.

I agree to pay all charges incurred during my pet/s stay at West Maui Kennels and agree to pay upon check out. This may include veterinary bills, flea treatment, reimburse for the cost of food, reimburse the cost of my pet damaging a kennel or other accrued charges.

West Maui Kennels will make every effort to keep all pets safe, however I recognize that there are inherent risks of illness or injury when dealing with animals in a country environment. Such risks include, but are not limited to problems resulting from excited running, rough play, sharp sticks or stones, fleas, ticks, etc.

I am aware that my pet will co-mingle with pets owned by different owners in a supervised environment unless otherwise specified during the consultation.

If my pet becomes ill or needs veterinary treatment I understand that I will be notified pursuant to the contact information I have provided when my pet was checked into West Maui Kennels. I support that West Maui Kennels takes any actions necessary to ensure the best care for my pet in the case of an emergency or veterinary treatment. If I cannot/do not immediately notify West Maui Kennels what measures I wish to be taken or in the event that emergency action is required, I agree that it is the sole discretion of West Maui Kennels to contact a veterinarian of their choice. The veterinarian may evaluate and treat my pet and my pet may be placed in veterinary care if deemed necessary. I agree to promptly pay for any such expenses incurred in connection with such veterinarian services.
